- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on July 16, 2018 at 12:00 PM U.S. Eastern Time (“ET”) and ends on August 10, 2018 at 11:59:59 PM ET (“Sweepstakes Period”). Administrator’s computer is the official Sweepstakes clock.
- 2. ELIGIBILITY:** This Sweepstakes is offered to legal residents of the fifty (50) United States, the District of Columbia, Guam, Puerto Rico, Canada (excluding Quebec), the United Kingdom, Malaysia, and New Zealand who have internet access are eighteen (18) years of age or older and the age of majority in their jurisdiction of residence at the time of entry. Employees, officers, directors, representatives, and agents of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, and companies involved in the implementation and execution of the Sweepstakes (collectively “Sweepstakes Entities”) and each of their respective immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. Winner's guest must be eighteen (18) years of age or older or the child/ward of winner.  - C. Total ARV of All Prizes:** The total ARV of all prizes in the Sweepstakes is 20,000 USD/25,670 CAD/14,529.92 GBP/78,448.10 MYR/28,429.50 NZD.
 - D. Odds of Winning:** The odds of winning a prize depends on the total number of eligible entries received during the Sweepstakes Period.
 - E. General:** All currency conversions based on listed exchange rates as of April 30, 2018. Prizes will not be redeemed or exchanged for cash, except where required by law. If a potential winner is a Canadian or Malaysian resident, before being declared a winner, he/she will be required to correctly answer a timed mathematical skill-testing questions without assistance, which will be provided with the e-mail notification or the prize will be forfeited. If the controversy or claim is not otherwise resolved through direct discussions or mediation, it shall then be resolved by final and binding arbitration administered by JAMS in accordance with its arbitration rules and procedures or subsequent versions thereof ("JAMS Rules"). The JAMS Rules for selection of an arbitrator shall be followed, except that the arbitrator shall be experienced and licensed to practice law in Michigan. All proceedings brought pursuant to this paragraph will be conducted in Oakland County, Michigan. The remedy for any claim shall be limited to actual damages, and in no event shall

any party be entitled to recover punitive, exemplary, consequential or incidental damages or have damages multiplied or otherwise increased, including attorneys' fees or other such related costs of bringing a claim, or to rescind this agreement or seek injunctive or any other equitable relief. Entrants agree that the rights and obligations of any Entrant and/or Sweepstakes entities and/or any other party shall be resolved individually, without resort to any form of class action. Any demand for arbitration must be filed within one (1) year of the time the cause of action occurred, or the cause of action shall be forever barred.
